9:25 am	 Emergency Preparedness - Wendy → Overview of Latest Emergency Drills The fire drills held on March 31 (Kent) and April 15 (Bacich) gave students another opportunity to evacuate to their emergency line-up locations. For the staff, the focus was to practice employing internal processes (deployment of safety teams, checking on supplies in the emergency shed, and supervision team practicing their role). The final drills of the school year at each site were held on April 29 (Kent) with an earthquake evacuation practice and on May 6 (Bacich) with a lockdown drill. The primary focus of the drills was to practice the Tag & Ticket process, with the deployment of members of the Student Release and Student Authorization emergency teams at both

	sites and the Gate team at Kent. About 10 parents at each school volunteered to pick up their children so that the teams could activate the Tag & Ticket student release steps. There were many learnings and take-aways from the drills that will help refine the steps that team members will take in the future. It served to better prepare the emergency teams for the larger scale emergency drill planned for the fall.
